# International Conference: "Gender Responsive Budgeting: Challenges and Practices" Prishting, Kosovo, 15 November 2012

# Introduction

The issue of equality between men and women has attracted a lot of attention at the central and local level. Fair share of municipal budgets is considered to be an important issue in pushing forward social, economic and democratic processes in Kosovo. Recently, decision makers, with the support of different international donors are inquiring new approaches in order to emphasize the gender issue. Therefore, gender responsive budgeting (GRB) is a new approach to combat gender inequality and to properly meet the needs of men and women by reflecting them in public policies.

The Republic of Kosovo has the adequate legislation that guarantees gender equality and equal opportunities. However, gender inequality in accessing financial resources and in spending public funds is challenging. Therefore, Agency for Gender Equality in the Office of Prime Minister of Republic of Kosovo organized the international conference on gender responsive budgeting.

The conference aimed to:

- Provide information on best practices and extend knowledge on gender responsive budgeting at the local and central level.
- Exchange instruments and instructions drafted about the way how to implement gender responsive budgeting at the local level.

## Conference: Conclusions, and Recommendations

## **Identified Challenges:**

- 1. Budgets that reflect gender perspective (including cross sectorial gender mainstreaming)
- 2. Gender disaggregated data and gender analyses.
- 3. Participation of Women in Decision-making Processes
- 4. Cooperation between Women at Local and National Level
- 5. Cooperation of Women from Different Political Parties
- 6. Slow implementation of Laws (especially those affecting gender issues)
- 7. Employment of women
- 8. Economic empowerment of Women
- 9. Education of women in rural areas
- 10. the budget circular reflecting gender perspective

#### Conclusions:

- 1. Gender budgeting is a new concept for the institutions and the society of Kosovo, thus its implementation is slow
- 2. Institutional mechanisms can be empowered by having clear budget lines. All institutions should be responsible for gender responsive budgeting.

#### **Recommendations:**

- 1. Gender budgeting should be enforced by law.
- 2. Before approving the Local and National Budgets to Conduct Gender Audits
- 3. Allocate Targeted Budget for Gender Issues in Local Level (including cross sectorial gender mainstream)
- 4. Gender analysis is needed to determine Budgets impact on men and women.
- 5. Develop Key Indicators to Measure the Progress of Gender Equality in Municipal and National Level
- 6. Increase Women Involvement in the Political Processes in Local Level
- 7. To Continue with the Application of the Quota for Gender Representation
- 8. Increase Cooperation between Women at Local and National Level Disregarding their Political Affiliation
- 9. Enforce the Implementation of the Laws (especially those affecting gender issues)
- 10. To Increase Awareness of Women and Man on Gender Equality
- 11. Increase capacities of Women in Specific Fields
- 12. Increase Cooperation between Women and Non-Governmental Organizations
- 13. Collect more gender disaggregated data's, Conduct Gender Analysis, and use such data's and analyses when developing Local/National Policies
