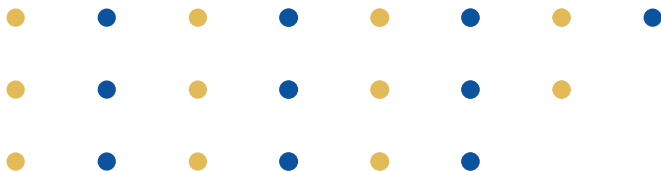

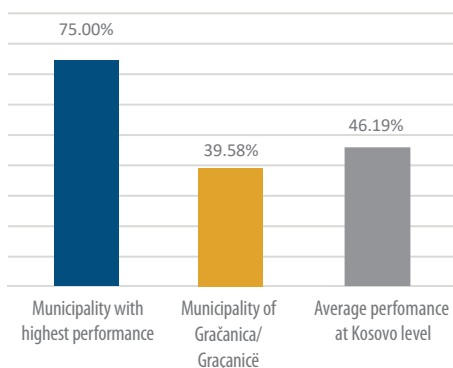
Overall Performance

Performance in 2019

The average performance of the Municipality of Gračanica/Gračanice in the 29¹ assessed indicators is 38 out of 96 possible points (39.58%).

Average performance of all municipalities is 46.19%.
The highest municipal performance is 75.00%.

¹ For the evaluation of the 2019 performance under the Municipal Performance Grant, out of 30 indicators, 29 indicators have been evaluated. This is because there were no official reported data for one indicator.

Field-level performance

The average performance in the 13 indicators assessed under the field of '**Democratic Governance**' is 18 out of 40 possible points (45%).

The average performance of all municipalities is 49.67%.
The highest municipal performance is 82.50%.

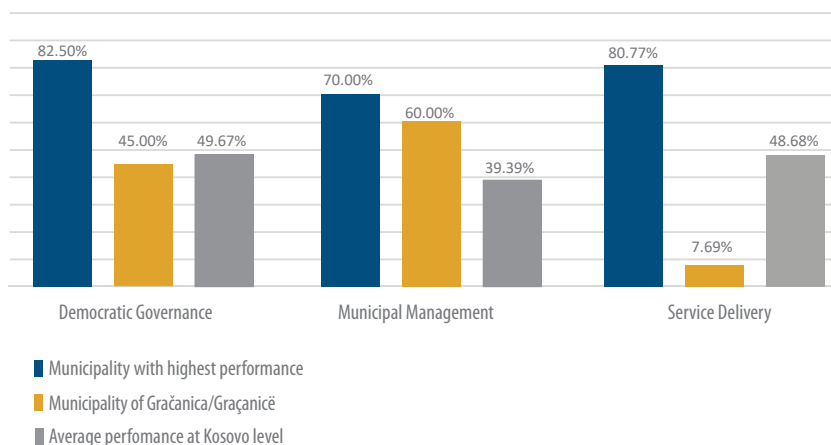
The average performance in the 8 indicators assessed under the field of '**Municipal Management**' is 18 out of 30 possible points (60%).
