
# OVERALL PERFORMANCE

The average performance of the Municipality of Obiliq/Obilić in the 28 assessed indicators is 54 out of 92 potential points (58.70%).

The average performance of all municipalities is 38.87%. The highest municipal performance is 69.57%.

For the performance assessment of 2020 within the Municipal Performance Grant, out of 30 indicators, 28 indicators were evaluated. This is because for two indicators there were no official data reported.

#### FIELD-LEVEL PERFORMANCE
